

TERMS AND CONDITIONS

INKSPIRE PROMOTION

1. The organizer of the promotion under the name „Inkspire Promotion” is Zortrax S.A. with its registered office in Olsztyn, at ul. Lubelska 34, code 10-409 Olsztyn, Poland entered into the register of entrepreneurs of the National Court Register kept by the District Court in Olsztyn, 8th Commercial Division of the National Court Register under the number KRS 0000564079, NIP 739-386-42-89, Regon 281551179, BDO number 000004381 ("Organizer"), e-mail address: sales@zortrax.com
2. The Promotion is held at the website <https://inkspire.zortrax.com/> („Inkspire Promotion Website").
3. The promotion does not apply to persons and entities residing or having their registered office in the following countries / territories: BURMA – MM, CENTRAL AFRICAN REPUBLIC – CF, COMOROS, CUBA, EQUATORIAL GUINEA – GQ, FALKLANDS, GUINEA BISSAU – GW, IRAN – IR, JOHNSTON ISLAND, KIRIBATI, KOREA, NORTH (NORTH KOREA), MAYOTTE ISLAND, MYANMAR – MM, NAURU, NIUE, SAINT PIERRE ET MIQUELON, SAO TOME & PRINCIPE, SIERRA LEONE – SL, SOLOMON ISLANDS, SOMALIA – SO, ST. HELENA (S. ATLANTIC), SUDAN – SD, SYRIA, TAJIKISTAN, TOKELAU ISLANDS, TURKMENISTAN, REPUBLIC OF – TM, TUVALU, WAKE ISLANDS, YEMEN, THE REPUBLIC OF - YE
4. The promotion consists in the possibility of purchasing Zortrax Inkspire series products via the Inkspire Promotion Website at a discounted price shown on the product card.
5. The promotion is intended for:
 - 1) adults with full legal capacity,
 - 2) entities running a business,- who during the Inkspire Promotion Period purchase products at the Inkspire Promotion Website. The condition for participation in the Inkspire Promotion is acceptance of the regulations of this Promotion.
6. Individuals and entities referred to in point 5 above will also be referred to as Promotion Participants.
7. The Promotion Participant who meets the conditions referred to in point 5 above, during the Promotion Period, is entitled to purchase products available on the Inkspire Promotion Website at a lower price, specified therein. The discount is 15% off the regular retail prices. Additionally, The Promotion Participant who purchases products on the Inkspire Promotion Website is granted free shipping of the purchased products. The discount granted cannot be exchanged for cash or a material equivalent.
8. The Promotion Participant may participate in the Promotion multiple times during its validity, provided that the conditions set out in these regulations are met each time.
9. The promotion is valid from March 17, 2021 to May 31, 2021 or until the stock last (Promotion Period).
10. Promotion Participant, who is a consumer within the meaning of Article 22[1] of the Polish Civil Code, is entitled to withdraw from the contract of sale of a product purchased under the Promotion within 14 days without giving any reason.
11. The provisions of point 10 shall apply accordingly to a natural person concluding a contract directly related to its business activity, if the content of this contract proves that it is not of a professional character for that person, resulting in particular from the subject of its business activity, made available on the basis of provisions on the Polish Central Register and Information on Economic Activities.
12. By participating in the Inkspire Promotion and placing an order via the Inkspire Promotion Website for one of the products covered by the promotion, Promotion Participant accept these Terms and Conditions.

15. All complaints regarding the Promotion may be submitted in writing or via e-mail to the Organizer's address provided in point 1. The Organizer acknowledges receipt of the complaint and handles it within 30 days of receiving the complaint by sending response to the Promotion Participant.
16. In matters not covered by these regulations, Polish law shall apply, including the provisions of the Civil Code, the Consumer Rights Act, and other relevant laws and regulations.
17. The Organizer reserves the right - for important reasons - to change these Terms and Conditions, provided that it does not infringe the rights acquired by Promotion Participants. In the event of a change to the Terms and Conditions, the Organizer will provide the text of the changed Terms and Conditions by publishing it at the Inkspire Promotion Website" (<https://inkspire.zortrax.com/>) and by means of a message sent to the e-mail address provided by the Promotion Participant. Amendments to the Terms and Conditions are effective from the moment they are clearly indicated.
